Message from the AACS President


The American Association for Chinese Studies held its 61st annual meeting from October 4-6 2019 at the University of Washington, with the University's Taiwan Studies Program cosponsoring the event.

COMONDO

2019 was an important commemorative year for many reasons: the hundredth anniversary of the May Fourth movement, the 70th anniversary of the founding of the People's Republic of China, the sixtieth of the disastrous demise of the Great Leap Forward of 1959, the fortieth of the Taiwan Relations Act of 1979, thirtieth of the Tiananmen uprising in 1989, and twentieth of the suppression of the Falungong religion and persecution of its adherents. Future generations may remember 2019 as the year of Hong Kong's discontent.

In recognition of the special importance of the centennial year of the May Fourth movement, six panels were devoted to various aspects of this complex phenomenon. Although the movement is best remembered for its influence on modernization and nationalism, but which also had far-reaching effects on the Sinicization of Marxism, on Confucian ideology, literature and film, constitution development, and even Buddhism. The AACS is grateful to the Chiang Ching-kuo Foundation for Scholarly Exchange to fund the participants of these panels. Plans are being made to publish them in book form.

Twenty four panels on social sciences, economics, the arts and humanities, and political science were available for the 80 participants to choose



among. Topics varied from perspectives on marriage equality in contemporary Taiwan, a comparison of early vampire literature in China and Germany, and a statistical analysis of the impact of the U.S.-China trade war on Taiwan's stock market.

At luncheon on the 5th, Director General of the Taipei Economic and Cultural Office in Seattle welcomed the participants to his city. The noontime keynote speech, "From Market Rescue To Deleveraging The History and Possible Future of China's Financial Policymaking," was delivered by President of the Taiwan Academy of Banking and Finance Dr. Hank C.C. Huang. It explored the stages of the PRC's economic development and the government's response to challenges encountered in the growth process. While crediting the efficiency of Chinese Communist Party's top-down design concept in forming a consensus on ideological issues, Dr. Huang noted that the CCP still lacks a clear direction in response to the Sino-U.S. trade war and to the reform of its institutions, despite agree that such reforms, if not taken, will pose severe challenges to continued growth.

Dr. Huang's address was followed by remarks from Professor William Lavely, Director of the University of Washington's East Asian Studies Program and a summary of UW's Taiwan Studies Program by its director, Dr. James Lin. Randall Nadeau of the Fulbright Foundation's Taiwan program presented options available for awards to study and work in Taiwan.

The evening keynote address, "China's Use of Film to Promote Soft Power in the Era of Xi Jinping and Donald Trump," was delivered by Professor Stanley Rosen of the Department of Political Science at the University of Southern California and a world-renowned specialist in film. Professor Rosen noted that, in its quest for world dominance, one area that China has targeted is its film industry, seeking to compete with Hollywood not only domestically, where it has done well, but also globally. However, China faces serious obstacles, some of which derive from a flawed concept and its measurement, as well as structural factors that have prevented any nation's film industry from competing with Hollywood.





FUTURE PLANS

THE UNIVERSITY OF DENVER HAS AGREED TO CO-HOST NEXT YEAR'S CONFERENCE, THE AACS'S 62ND. PROFESSOR ANDREW J. NATHAN, WHO HOLDS THE CLASS OF 1919 ENDOWED CHAIR OF POLITICAL SCIENCE AT COLUMBIA UNIVERSITY AND IS AN EXPERT ON CHINESE DEMOCRACY, WILL DELIVER THE LUNCHEON ADDRESS. WE ARE EXPLORING CULTURAL PROGRAMS FOR THE EVENING KEYNOTE PRESENTATION. But China's own contradictory priorities and its self-imposed constraints also share responsibility. Despite yearly spending of over 10 billion USD on soft power, China has repeatedly been willing to sacrifice potential gains in soft power in pursuit of higher priorities. In China's hierarchy of values, influencing the behavior of other countries – and punishing them for "anti-China policies" -- has taken precedence. In addition, Chinese soft power is focused more on the domestic audience, since political and social stability at home are China's paramount values. This in turn requires state control of civil society. Unlike American soft power, which has been most successful when it is separated from government – e.g., Hollywood films – Chinese soft power has not only been inseparable from government initiatives but, in the case of the film industry, these initiatives - e.g., censorship - have often been taken with no explanation, leading to a further erosion of soft power.

2019 Conference Summary

Lunch Keynote Address

"The Chinese model of finance: global economy, embracing from the 2018 crisis to private ownership and the deleveraging and beyond" market economy to maintain

Summary: China's reform and opening allowed it to become reintegrated into the global economy. In particular, the introduction of market mechanisms following its induction into the WTO modernized its entire political and economic system, helping it move away from the previous dictatorship of the Communist proletariat. Since this time, the objectives of maintaining the socialist struggle against the bourgeoisie while simultaneously joining the

private ownership and the market economy to maintain steady growth and prevent the fate of the former USSR, have become persistent challenges. This paper will explore each stage of China's economic development, including the role of world factory after entering WTO and the global economy rescuer with her fourtrillion-yuan investment package in the financial crisis in 2008. It will discuss the results and influence of fiscal and monetary of China's government, in particular analyzing the causes of liquidity crises that occurred from 2013-14, and the

government's response, elucidating China's differences with market democracies. Finally, it will also analyze China's thinking and possible future developments following the trade war in 2018. Although the top-down design concept can efficiently form a consensus on ideological issues, the Party still lacks a clear direction in response to the Sino-US trade war. If China is unable or unwilling to reform its institutions, it will face severe challenges to further growth.

Dinner Keynote Address



Professor Stanley Rosen (US-China Institute, University of Southern California)

"China's Use of Film to Promote Soft Power in the Era of Xi Jinping and Donald Trump"

Summary: Almost a decade ago a Chinese "Blue Book (lanpishu)" on soft power noted pessimistically that the United States held 43% of the soft power in the world while the European Union accounted for 34%. Excluding Japan and Australia, China and the rest of Asia was limited to less than 4%. Two years into the presidency of Donald Trump, the evidence of the decline in the American image internationally from multiple surveys is overwhelming. Has China has been able to reap the rewards from the American decline and, if so, are China's gains sustainable? One area China has targeted is its film industry, seeking to compete with Hollywood not only domestically, where they've done well, but also globally. However, China faces serious obstacles, some of which derive from a flawed concept and its measurement, as well as structural factors that have prevented any nation's film industry from competing with Hollywood. But China's own contradictory priorities and its self-imposed constraints also share responsibility. Despite yearly spending of over 10 billion USD on soft power, China has repeatedly been willing to sacrifice potential gains in soft power in pursuit of

higher priorities. In China's hierarchy of values, influencing the behavior of other countries – and punishing them for "anti-China policies" -- has taken precedence. In addition, Chinese soft power is focused more on the domestic audience since political and social stability at home are China's paramount values. This in turn requires state control of civil society. Unlike American soft power, which has been most successful when it is separated

Theatre of Our Time: 2020 NTU International Theatre Conference

In the 1960s, new forms of theatre have been explored in the US and Europe, including collective improvisational theatre, community theatre, political theatre, educational theatre, and cross-disciplinary theatre, thereby making great impact on how people think about modern theatre and how to put it into practice. Due to the efforts of modern theatre-makers, major Western theatrical concepts, such as the works of Dario Fo (1926-), the "Poor Theatre" by Jerzy Grotowski (1933-1999) or the "Theatre of the Oppressed" by Augusto Boal (1931-2009), were introduced into Taiwan, exposed among more and more local audience groups.

However, everything that was once deemed as "modern" seems somewhat distant from us now.

Since the 21st century, the number of theatre troupes has skyrocketed, theatre productions flourished, and theatrical concepts and techniques, greatly different from one another, have blossomed. With the advancement of technology, the division of labor in theatrical production has undergone reformation, theatre elements, techniques, and aesthetics have faced constant renewal, and even our notions of "theatre" have been challenged.

Ever since the end of 19th century, traditional Asian theatre has endured wave after wave of invasions from Western theatre. The oppression brought on by the dominant Western culture is no less vicious than any political colonialism in the past. Not limited by region borders, struggles between the periphery and the center have been taking place nonstop everywhere.

After several rounds of contestations, the "modernity" of traditional theatre finally arose out of the negotiations between "protection of tradition" and "transitional innovation." When theatre-makers are facing modern audiences and performing for them, however, whether they are to "protect" or "innovate," "re-making of tradition" becomes a process that is destined to be questioned and reconstructed repeatedly. Then there are collaborations between countries, between different traditions, and between the traditional and the modern, which are all stimulating their own imaginations and creating new practices.

The situation in China is guite unique. Since the Chinese economic reform, economy has risen sharply, bringing about rapid changes in material consumption, causing changes in people's perceptions, views and national selfconfidence, and bringing tremendous impact on theatre production as well. With the "rise of China," set construction and theatre forms have 8. performance and social engagement undergone significant innovation and the Chinese diaspora all over the world involved in theatre have responded to this change.

At the same time, however, the "globalized" society is experiencing various "great declines" in economy, politics, belief, and value system, etc. The era we are now living in has brought us a collective sense of disappointment and even frustration. How has this changed our mentality and cultivated the zeitgeist of the "contemporary" theatre?

The word "contemporary," compared with "ancient" and "modern," proactively describes the era we are living in. As time moves on and creative works are continually being produced, the demarcation of "the contemporary" should be constantly re-considered and adjusted. With this awareness in mind, we want to probe into the following questions: after riding through an array of political, aesthetic, and philosophical trends, what characteristics does "the Theatre of Our Time" have that embody the zeitgeist and aesthetics of this current era? Moreover, does it honor the spiritual values and ideals in this consumerist and materialist world, and if so, how?

This is an age when people cannot look away from their phones even while walking and

driving, when watching video clips that go over movies in a few minutes is more popular than watching the movies themselves, and when people turn to cloned pets and possibly cloned lovers for companionship. In a world like this, are theatre and drama going to be the same as they once were?

This conference is calling for papers closely related to the central theme, "the Theatre of Our Time," and its various surrounding leitmotifs listed below:




